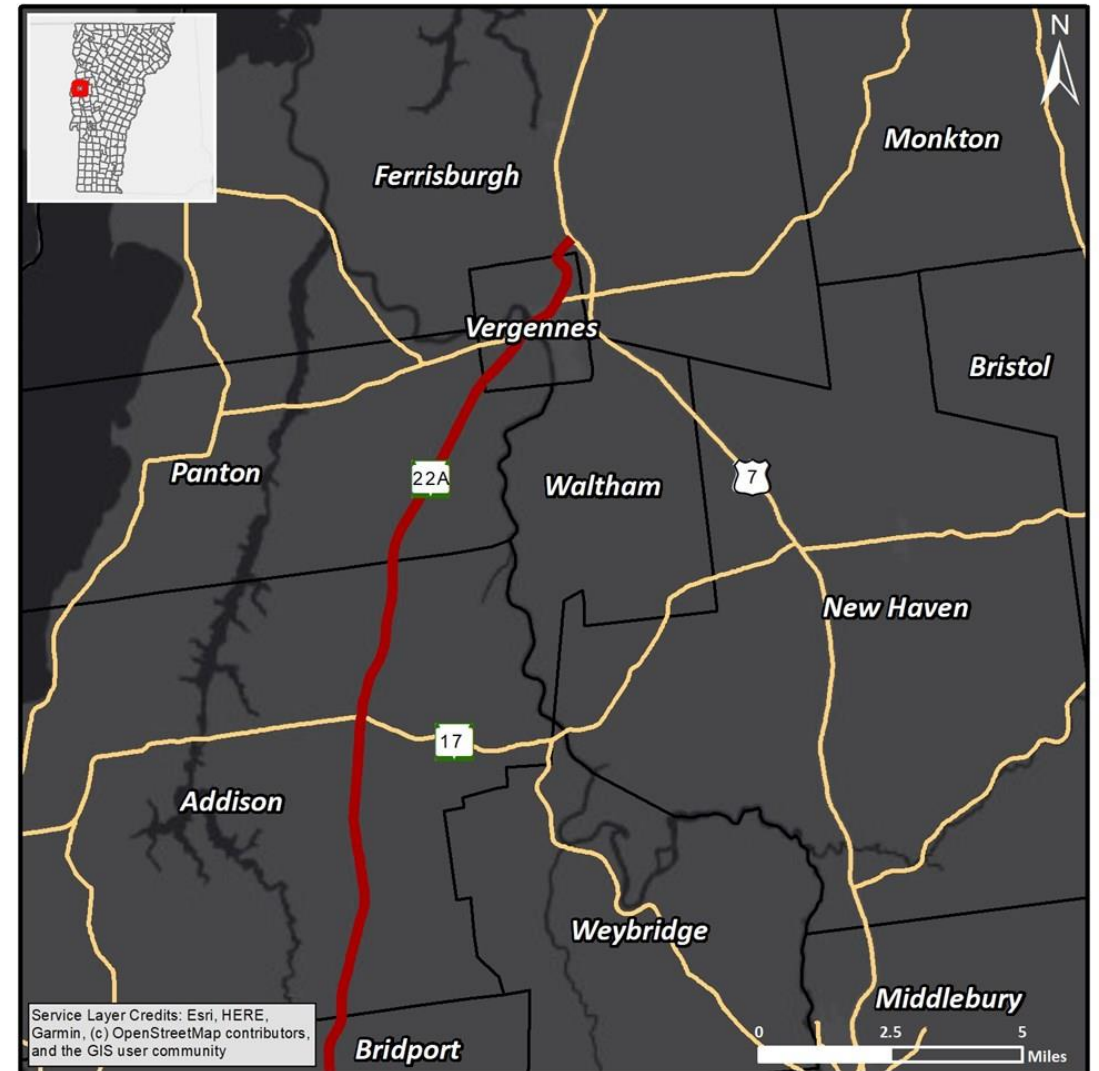


# Vergennes PEL Study Purpose

To reduce impact (noise, vibration, fume and dust) of large truck traffic on VT Route 22A and Downtown Vergennes, while seeking ways to enhance the quality of life and economic vitality for residents in the City and surrounding towns.

## Priorities:

- Maintain a high level of service for the movement of freight in the region;
- Minimize and/or mitigate truck and traffic impacts to other transportation corridors;
- Coordinate transportation investments with local land use plans
- Minimize property and environmental resource impacts in neighboring communities;
- Support the continued movement of non-truck traffic through downtown Vergennes; and
- Provide a cost-effective use of resources.



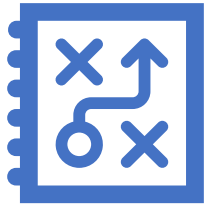
# Vergennes PEL Study Project Outcomes

- Land Use Plans in most affected municipalities
- Identification of Short List of Alternatives for Federal Environmental Review

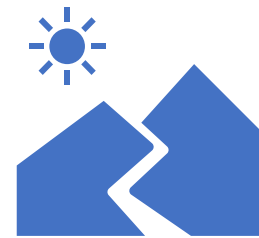

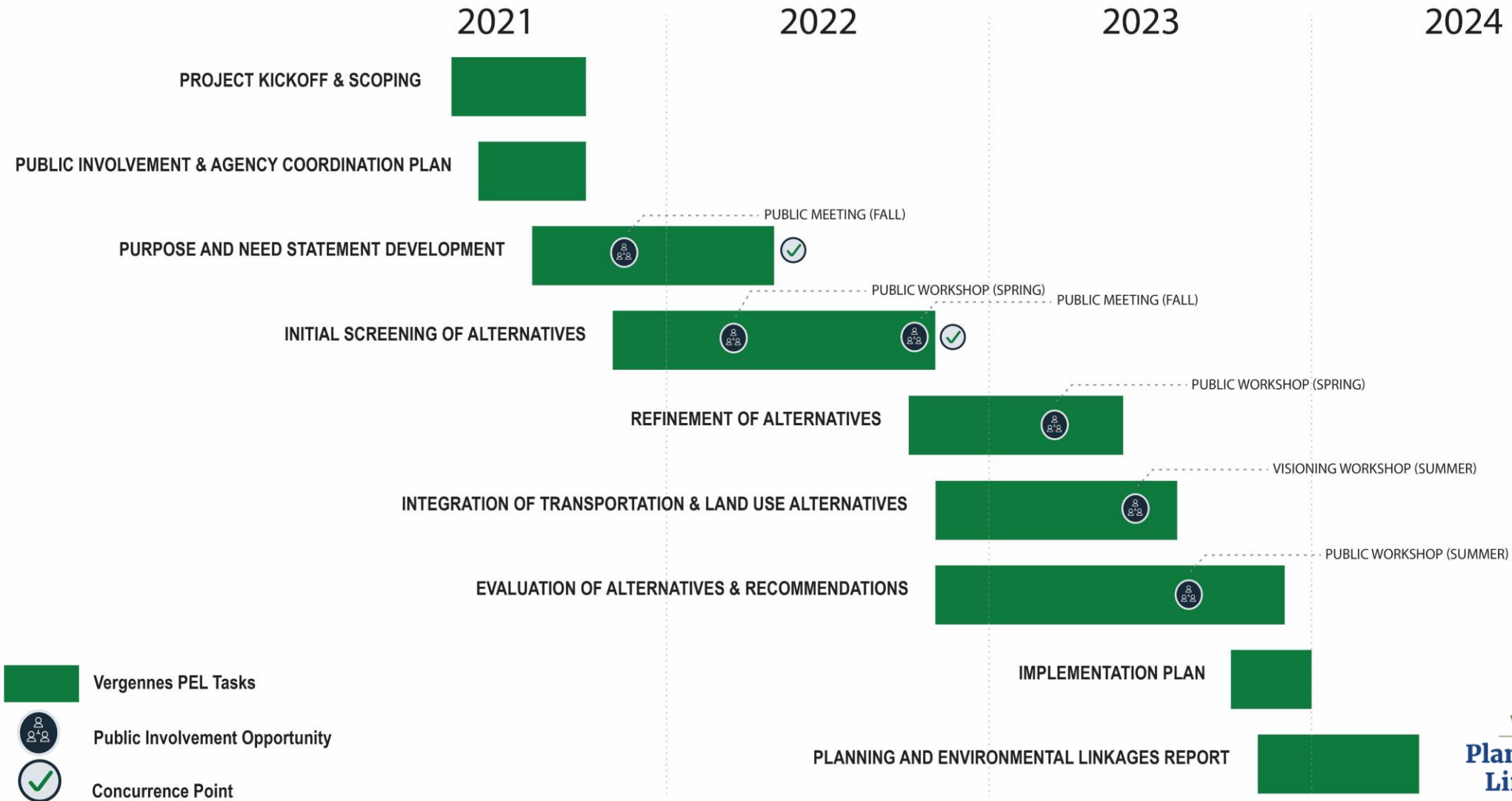
