

Purpose of Agency Coordination Plan

- Guide coordination activities through the duration of the Vergennes PEL Study with interested, involved agencies that may be likely cooperating and participating agencies under NEPA
 - Cooperating federal agency that has jurisdiction by law or special expertise with respect to any environmental impact involved in a proposed project or project alternative
 - Participating agencies with an interest in the project
- VTrans will use information developed in the Vergennes PEL Study to inform the NEPA process for capital projects that are initiated subsequent to this study
